The Nashik Metropolitan Region Development Authority (NMRDA) invites Expression of Interest (EOI) from eligible, experienced and practicing Advocates/Law Firms for empanelment to represent NMRDA before:

- Bombay High Court, Mumbai
- Civil Courts at Nashik
- Revenue Authorities
- Tribunal/Quasi-Judicial Authorities
- Other Judicial Forums as may be required

1. Scope of Work

The empanelled Advocates/Law Firms shall provide legal services including :

- Representation before Courts and Tribunals
- Filing of Writ Petitions, Civil Suits, Appeals, Affidavits, Replies, Written Statements, etc.
- Legal opinions and advisory services
- Drafting and vetting of agreements, notices and legal documents
- Appearance before Government Authorities
- Land acquisition and development related legal matters
- Arbitration and dispute resolution matters
- Any other legal work assigned by NMRDA

2. Eligibility Criteria

For Individual Advocates :

- Enrolled with Bar Council of Maharashtra & Goa
- Minimum 5 years' active practice for Civil Court matters
- Minimum 7 years' active practice for High Court matters
- Experience in Government/Semi-Government/Development Authority matters preferred
- Experience in MLRC Act, 1966, civil, M.R. & T.P. Act, 1966, constitutional and development authority matters desirable

For Law Firms :

- Registered law firm with adequate legal team
- At least one partner having requisite court experience
- Proven experience in handling litigation matters before High Court/Civil Courts

3. Documents Required

Applicants shall submit self-attested copies of :

- Bar Council Registration Certificate
- Aadhaar Card/PAN Card
- GST Registration (if applicable)
- Experience details and profile
- List of important cases handled
- Office address and contact details
- Undertaking regarding non-blacklisting
- Any other relevant supporting documents

4. Empanelment Period

The empanelment shall remain valid for a period of Three (3) Years, extendable based on satisfactory performance and requirement of NMRDA.

5. Selection Procedure

- Applications shall be scrutinized by the competent committee constituted by NMRDA.
- NMRDA reserves the right to accept/reject any application, seek additional information, conduct interview/personal interaction, or cancel the EOI process without assigning reasons.
- Mere submission of application shall not confer any right for empanelment.
